

I also congratulate all the GBCL team for their tireless effort in making this publication possible.

# Staffing profile of Green Bhutan Corporation Limited for the year 2019

Total staff at GBCL as of 31<sup>st</sup> December 2019 is 63 numbers. The staffs are recruited under four different types of appointment. 1 regular contract, 13 are regular, 24 are on consolidated contract and 25 are under Direct Employment Scheme (DES) through the support from Labor Ministry.



GBCL requited all assistant managers as regular employee from 15<sup>th</sup> August 2019 after serving 2 years under DES support from the Labor ministry. The field supervisors and staffs in all the central nurseries are recruited on consolidated contract for two years based on their performance. This staffing pattern benefits the company as plantation and nursery works are seasonal and it also helps maintains a small, compact and efficient group of hard working people.

76% of our total staffs are working in various plantation and nursery sites while 24% of us work in the head office in Thimphu.

# **Scopes of the Report**

The annual report presents different activities implemented from 1st January 2019 to 31st December 2019 as mentioned below.

#### **Source of Revenue**

Green Bhutan Corporation Limited is mandated to carry out any kind of afforestation plantation across the country and for this the government and other relevant sectors sanction budgets annually, which comes as the main source of our revenue. At the same time the plantation maintenance budget also comes as another source of income. Apart from this GBCL has been carrying out landscape development works at various places and have been a successful implementer so far.

The source of revenue for the company has been reflected in the table below:

As mandated GBCL is looking to collaborate with national or international parties in carrying our afforestation, landscape development works and even environmental consultations.



#### **Central Nurseries Establishment**

The Eastern, Western and the Southern Central Nurseries are being established at Nanglam, Sarpang and Zekha. The nurseries will be able to produce seedlings for all the plantation and nursery works to be carried out by the company. Each year GBCL carry out about 400 hectares of new plantation creation and the maintenance of the plantation from previous year until fourth year after the creation. Almost numbers of seedlings are planted each year.

Smaller nurseries like the ones in Lumetsawa and Trashiding produce ornamental and flower species that are mostly used during the landscape development works. The Lampelri nursery mainly focus on the production of medicinal plants and few higher altitude plantation saplings. We also have one out sourced nursery at Sertsam, Lunthse, by the Bumdeling Wildlife Sanctuary. It was established to raise wild fruit bearing sapling species for improving Hornbill habitat within Bumdeling Wildlife Sanctuary area. Seedling dominating within this nursery is *Percea fructifera* (Gulishing).



# **Plantation and Maintenance**

In 2019 GBCL created a total of 211.36 Hectares of Plantation across the country. (10 Ha in Chhukha, 13.2 Ha in Mongar, 10 Ha in Dagana, 33 Ha in Thimphu, 60 Ha in Trashigang, 20 Ha in Paro, 6 Ha in Wangdue, 37 ha in Punakha, 17.13 Ha in Pemagatshel, and 5 Ha in Samdrup Jongkhar) Dzongkhags. The plantations activity were funded by RGoB, and PHPA.

A total of 188 Ha of Maintenance was also carried out under three Dzongkhags; Wangdue Phodrang (83.75 ha), Punakha (19.1) and Tsirang (85 ha) all funded by the PHPA hydro project.

# **Landscape Development Works**

#### **Samtse Damdum**

The Plantation works at Damdum Industrial Park, Samtse has been awarded to Green Bhutan Corporation Limited (state Owned Enterprise) by the Damdum Industrial Park, Department of Trade under Ministry of Economic Affairs. It has been successfully completed on 21<sup>st</sup> July 2019; and handed over to Damdum Industrial Park Management on 22<sup>nd</sup> July 2019. Following plants species were planted and handed over to them.

#### Dawakha, Paro

After several consultation meetings with the Department of Geology and Mining under Ministry of Economic Affairs, GBCL was awarded the mine area restoration landscape works at Dawakha. An area of 7 Ha was restored by planting trees and ornamental plants to improve the soil and vegetation of the area. A pond was also developed to harvest the monsoon rain water as the area is extremely dry.

With continuous support from the DGM it was successfully executed and the area will be handed over to the department once the area is properly established.

#### Thimphu IT Park

The Construction Development Corporation Limited awarded landscape and greening work around the newly constructed Tech Park. GBCL planted ornamental plants such as Magnolia, Azalea, Camellia and other flowering plants to add to the aesthetic value of the surrounding. The Tech Park is one of the largest park in Bhutan.

#### **Social Forestry Day Celebration**

The Social Forestry Day in Bhutan was launched under the wise guidance of His Majesty the Fourth Druk Gyalpo in 1979. Since 1985, it is being observed on 2<sup>nd</sup> June which is the Coronation Day of the Fourth Druk Gyalpo.

On 2<sup>nd</sup> June 2019, 10 staffs from the head office and field technicians working at the landscaping site celebrated the social forestry day at IT Park area by planting 32 numbers of ornamental plants. Every year, GBCL staffs participate in plantation program to mark the significance of the day and to fulfill the green visions of our beloved leaders.



# Daga town, Dagana

With the signing of MOU between GBCL and Dagana Dzongkhag, landscape development works were awarded to GBCL. The area above the town (1.2 acres) was developed into a public park with facilities like children play area, gazeboes and a water pond.

With constant guidance from the Dasho Dzongda personally and all the Dzongkhag officials the development works was successfully executed and the park was handed over to the Dzongkhag in 2019.

#### **Zero Waste Hour**



#### **Director's Report**

#### DIRECTORS' REPORT 2019

Dear Shareholder,

On behalf of the Board of Directors, Green Bhutan Corporation Limited, I am pleased to report on the Company's performance for the year ended 31<sup>st</sup> December 2019 in this 18<sup>th</sup> Board Meeting cum 3rd Annual General Meeting of the Company held at Thimphu, today on the 08<sup>th</sup> April 2020.

#### Background

Green Bhutan Corporation Limited was incorporated on 14<sup>th</sup> July 2016 and was formally launched on 3<sup>rd</sup> January 2017. GBCL was incorporated as a100% State Owned Enterprise (SoE) under the Companies Act of Kingdom of Bhutan 2016 with the government's equity of Nu.33.33 million and additional equity in kind worth of Nu. 8.173 million with core mandates of reafforestation and afforestation, landscape development and greening, development of recreational and botanical parks, establishing nurseries of medicinal and ornamental plants; and floriculture, providing awareness on environmental policies and programs.

#### **Financial Achievements**

The Company has generated a total revenue of Nu. 42,288,540.38 and incurred a total expenditure of Nu. 42,375,697.11 comprising expenditures for material consumed (direct cost), employee benefits, administrative and other expenses. The financial achievements for the year 2019 is much reduced in comparison to the previous years (2018) and (2017). This can be attributed to the fact that the Company was largely under government review in 2019 creating an uncertain environment which led to a loss of deposit work awards from regular clients due to reduced confidence in the Company's future as well as the hampering of planned work programs due to the prolonged review and the resulting impact on staff's ability to carry out planned work without disruption. Notwithstanding all these, the Company has still made a gross profit of Nu. 3.396 million before depreciation and amortization expenses; and income tax.

#### **Non-Financial Achievements**

GBCL has created 211 ha of new plantations and carried out maintenance on 188 ha of old plantations during the year. A public recreational park has been developed at Dagana under Dagana Dzongkhag. A landscape development work was carried out at Samtse Industrial Park. GBCL also started working with DGM and took over a quarried site at Dawakha and carried out environmental restoration plantation.

The Management has also finalized the GBCL Procurement Manual 2019 which was also approved by the Board. Further, the company also finalized the Employees Award and Recognition Guidelines with approval from the Board, in order to motivate the employees.





#### Corporate Governance and Monitoring System

The GBCL Board constitutes of five Board Directors including the Chief Executive Officer. The Board provides strategic direction, guidance and monitors the performance of the company on a quarterly basis; and as and when required. The Board meetings are conducted on a quarterly basis and also conducted depending on the urgency of the matter. The GBCL Board had four Board Meetings during the year. The Company also has initiated a Cost and Benefit (CAB) exercise at unit level to Division level for cost control and performance improvement.

#### **Revision of Mandates:**

As per the directives of the National Review Team for SoEs and Review Team of MoAF, the mandates of GBCL has been revised as follow:
